**\*\*\*\*ATTENTION EXHIBITORS\*\*\*\***

These shows will be judged and run by the Show Rules of the Australian Shepherd Club of America. Dogs must be ready for judging. Neither the club nor the chairman will be responsible or obligated to furnish any services for notifying exhibitors or their agents of class judging. Entry fees will not be refunded in the event a dog is absent, disqualified, excused, or barred from competition by action of the show committee. Entry fees will only be refunded if the refund request is received before the pre-entry closing date, no entry fee will be refunded if the show cannot be opened or completed by reasons or riots, civil disturbances, fire, Acts of God, or public emergency. The show-giving club, the Show Chairman, their agents, officers, and/or committee shall assume no responsibility for injury to children. Judges may be substituted. All dogs must be leashed or crated at all times, except when competing. No electrical and /or mechanical training devices will be permitted on the show grounds. Please clean up after your dogs. For the safety of your dogs and others, all dogs must have current vaccinations against rabies, distemper/parvo, you are asked to bring a copy of the rabies certificate with you.

**HERDING SPECIFICATIONS** The herding trials are open to all breeds on first come, first serve basis. The trials will consist of a maximum of 40 runs per judge, or until stock limitations are reached. Handler is responsible for his dog and must keep the dog under his control at all times. Dog will be brought to and from the ring on leash. Handler will be responsible for any injury caused by their actions or that of their dog. Owner of any dog causing any livestock losses will be charged \$400.00 per cow, \$125.00 per sheep or \$15.00 per duck. Runs will be determined randomly prior to trial. Bitches in season will run last and must be crated away from the arenas at other times. Ducks 5 head--- cattle 3 head --- sheep 3 head unless otherwise announced at handlers meeting.

**NOTE:** Non ASCA registered dogs competing in ASCA trials will need a tracking # issued by ASCA to earn ASCA titles. Entries without a tracking # will not count towards titles/awards. Go to: [www.asca.org](http://www.asca.org) for entry forms, rules, & tracking #'s.

## **DIRECTIONS TO TRIAL SITE:**

**From the North (Lynchburg):** US 29 south expressway to US 501. Follow Rt. 501 through Rustburg. Approximately 3 miles south of Rustburg, turn right onto State Route 701 (East Ferry Rd.). Farm is approximately 1 mile on right. Large black mailbox "JOHNSON 1049" on it. Come in driveway and follow through barnyard.

**From the West:** US 460 East to US 29 South. Turn left onto Virginia 24 at 5th traffic light. Follow 24 to US 501 in Rustburg. Turn right (south) onto 501. Approximately 3 miles turn right onto SR 701 (East Ferry Rd.) Farm is approximately 1 mile on right. Large black mailbox "JOHNSON 1049" on it. Come in driveway and follow through barnyard.

**From the South (Danville):** US 29 North to Virginia 24. Turn right (east) on 24 at traffic light. Follow 24 to US 501 in Rustburg. Turn right (south) onto 501. Approximately 3 miles turn right onto SR 701 (East Ferry Rd.) Farm is approximately 1 mile on right. Large black mailbox "JOHNSON 1049" on it. Come in driveway and follow through barnyard.

**From the South (Durham):** US 501 North through Gladys. About 5 miles north of Gladys, turn left on SR 701 (East Ferry Rd.). Farm is approximately 1 mile on right. Large black mailbox "JOHNSON 1049" on it. Come in driveway and follow through barnyard.

**From the East:** US 460 West to Virginia 24 at Concord Traffic light at intersection. Turn left (west) on Rt. 24 and follow to Rustburg. Follow 501 and 24 through Rustburg. Stay straight on 501 South (24 will split off to right after Rustburg). Approximately 3 miles south of Rustburg turn right onto SR 701 (East Ferry Rd.). Farm is approximately 1 mile on right. Large black mailbox "JOHNSON 1049" on it. Come in driveway and follow through barnyard.
